1. The number of section of the school shall be restricted to 34 as per the number of class rooms reported and shall not be increased by the school without specific approval of the Board and apply online for increase in sections, if any, as per rule 15:7 of Affiliation Bye-Laws.
2. Earlier the name of society Arya Pratinidhi Sabha and now the name of the society is Dayanand Bal Vidya Mandir School is required to give explanation how school has changed society without the approval of state and C.B.S.E.
3. School is required to submit copy of Compact land certificate.
4. School is required to submit copy of Renewed Certificate of Fire safety duly issued from concerned Competent Authority of the State Government

Keeping in view the academic interest of the students, extension of general affiliation may be extended upto 31.03.2021 provisionally with deficiencies and the school is allowed to register their bonafide students of class IX/X/XI & XII accordingly as per eligibility and norms of the Board.

You are requested to make definite compliance on above points at the earliest not later than 30 days from the date of receipt of this letter to enable this office to take further necessary action in the matter for the regularization of further extension of general extension beyond 31.03.2018 on your online request vide registration no. EX-00693-1819.
